## Sound Permit

- A "Sound Permit" is required for any event that occurs on the OSU Campus and will use amplified sound. Amplified sound is defined as anything more than a "boom box."
- Sound permits will not be issued for more than 2 consecutive hours during academic times (Monday Friday 7 am-5 pm)
- Sound Permit applications must be submitted via email 14 days prior to the event. Late request will not be granted.

## **OSU Amplified Sound Conditions**

In order to gain approval of the submitted OSU Sound Use Permit, the applicant must read and complete the following check-list.

Read item and complete the form:

- The "Responsible Person" will be available throughout the event to respond to and cooperate with OSU Public Safety/ Oregon State Police and Facility Representative.
- The "Responsible Person" will turn down or terminate amplified sound upon citizen complaint at the direction of OSU Public Safety/ Oregon State Police or Facility Representative.
- The "Responsible Person" must coordinate with OSU Public Safety/ Oregon State Police so that people do not gather on the surrounding streets thereby impeding traffic.
- Amplified sound will terminate by am/pm
- A valid noise complaint may result in forfeiture of a further sound permit(s) for the remainder of the school/ calendar year.
- If, at any time, the noise extends beyond the limits stipulated on the permit application/conditions, an OSU Public Safety Officer/ Oregon State Police Trooper will immediately revoke this permit.
- Noise level will not exceed 50 dB during academic terms at the base of the nearest building to the vicinity of the
  event venue or 110 dB on the weekends, 30 ft from the speakers/sound amplifying equipment.

## 576-018-0140 On- or Off-Campus Noise Control Policy

- (1) Recognized student organizations must register any event to be held on or off campus if the event involves high volume noise the public might hear.
- (2) Outdoor events that involve high sound levels (such as the use of amplified sound, musical instruments and crowd noise) must be authorized by the Student Involvement office and must be terminated by 11 p.m. unless a specific permit has been obtained.
- (3) A person at the event must be designated to respond to noise complaints. If the noise cannot be controlled, the event must be terminated.
